This award reflects 39,443.8633 shares less the 1,121.8828 shares withheld for taxes. For the purposes of determining the timing and amount of payment, the award is considered earned over the period since January 1, 2011 through April 15, 2011 with the appropriate part deemed granted on the fifteenth and thirtieth of each month.
