- One third of the 2022 Restricted Stock Units ("2022 RSUs") vested on February 22, 2023, the first anniversary of the grant date, and the remaining 2022 RSUs will vest in equal amounts on each of the second and third anniversaries of the grant date, subject to the reporting person's continued employment through each applicable vesting date, and settle in shares of AIG Common Stock.
- One third of the 2022 Stock Options vested on February 22, 2023, the first anniversary of the grant date, and the remaining stock options will vest in equal amounts on each of the second and third anniversaries of the grant date, subject to the reporting person's continued employment through each applicable vesting date.
- One third of the 2023 Restricted Stock Units will vest in equal amounts on each of the first, second and third anniversaries of the grant date, February 21, 2023, subject to the reporting person's continued employment through each applicable vesting date, and settle in shares of AIG Common Stock.
- One third of the 2023 Stock Options vests on each of the first, second and third anniversaries of the grant date, February 21, 2023, subject to the reporting person's continued employment through each applicable vesting date.
