- These securities do not carry a conversion or exercise price.
- This award represents fully vested RSUs; one third of the award will be payable in cash based on AIG's share price on the first anniversary of the deemed grant date, one third based on AIG's share price on the second anniversary of the deemed grant date, and one third based on AIG's share price on the third anniversary of the deemed grant date. This award reflects 6,843,7408 shares less 179,1879 shares withheld for taxes.
- Represents the payment in cash of \$101,857.99, before applicable taxes, in settlement of stock salary based on AIG's share price on August 30, 2012.
