The remaining 2013 Performance Share Units vest in January 2018 and are settled in shares of AIG Common Stock.
- These securities convert to AIG Common Stock on a 1 to 1 basis.
- Represents the remaining 2014 Performance Share Units earned as determined by AIG's Compensation and Management Resources Committee in January 2017 based on pre-established performance goals for the three-year performance period ended December 31, 2016. The remaining 2014 Performance Share Units vest one-half in January of each of 2018 and 2019 and are settled in shares of AIG Common Stock.
- The 2017 Restricted Stock Units vest in January 2020, subject to the reporting person's continued employment through the vesting date, and are settled in shares of AIG Common Stock. The award includes dividend equivalent rights payable in the form of additional Restricted Stock Units.
