The earned 2018 Performance Share Units (including related dividend equivalent rights in the form of 2018 Performance Share Units) vested on January 1, 2021, and are settled in shares of AIG Common Stock.
- The 2021 Restricted Stock Units convert to AIG Common Stock on a 1-to-1 basis.
- Represents the grant of 2021 Restricted Stock Units. The 2021 Restricted Stock Units vest on January 1, 2024, subject to the reporting person's continued employment through the vesting date, and are settled in shares of AIG Common Stock. The award includes dividend equivalent rights payable in the form of additional 2021 Restricted Stock Units.
